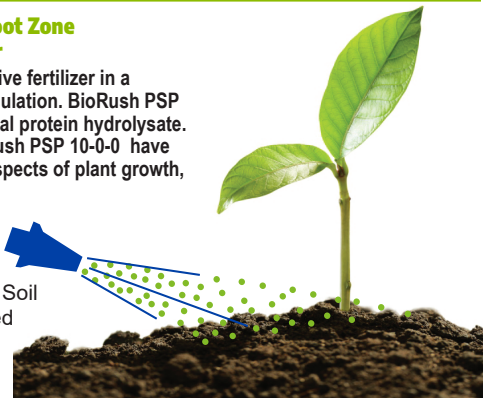

APPLICATION

BioRush PSP 10-0-0 is suitable for use on all growing plants.

BioRush PSP is miscible with most common pesticides and fertilizers. Before using we recommend jar testing to evaluate compatibility with other products. Incorporate BioRush PSP last while maintaining agitation in the mixture.

UNDER NORMAL CONDITIONS

Field Crops and Vegetables: Apply 10 to 20 oz. per acre on 14-28 day intervals

Orchards and Viticulture: Apply 8 to 16 oz. per acre on 14-28 day intervals

Turf Grass, including Tees, Greens, Fairways, Roughs, Lawns and Parks : Apply 12 to 22 oz. per acre on a 7-14 day intervals

Horticulture, Greenhouse and Nursery: 4-10 oz per acre

Injection: 2-7 oz per 100 gallons

Backpack Sprayer: 1 Tbs per gallon
